The accounts for the year ending 31st March 1922 audited by W^m Francis Pottenburg and the relative vouchers were laid before the meeting.

The Chairman explained that a new mower and rake were required and that the gardener's box in the lane needed repairs. W^m Strain offered to present the Terrace with a new mower which he had and intimated that he had given the gardener a store for the toolhouse. His offer was gladly accepted and he was accorded a hearty vote of thanks for his kindness. It was resolved to purchase a new rake and to leave the chairman to arrange for repairs to the toolhouse and to get grass seed and sand for the ground.

The question of painting the railings was raised.

After discussion it was resolved to leave the matter over till next year.

The Hon^y Secretary read the excerpt from the minutes
of meeting of 21st April 1925 relating to the trees and bushes,
and explained that he had taken the advice of Mr Matthews
Superintendent of Parks Glasgow Corporation. He reported that
Mr Matthews had advised that a certain amount of
pruning should be done and a few trees taken out.
After full discussion the proprietors remitted the matter to
a sub-committee consisting of Mr Wan and Mr Young
with full powers to instruct pruning and the removal
of such trees as thought desirable to cut down subject to

the consent of the proprietor concerned being obtained before any tree opposite his house is removed. The Hon Secretary also reported that Mr Matthews had offered the services of the Corporation foresters for the work on payment of their time only and the Committee were instructed to avail themselves of this offer. Mr Matthews thought that the cost would not exceed £10. in all.

The question of the Tramway stopping place opposite the centre of the Terrace was raised and the Hon Secy was instructed to write The Tramways Manager and ask him to remove the stopping place to one end of the Terrace or the other and if no satisfaction could be obtained to raise the question of constructing a small gate in the centre of the Terrace at the next meeting.

The minutes of the last two meetings were read and
approved and signed by the Chairman.

The meeting placed on record their sense of the great loss
which the Tenace had sustained through the death of Mr
Hugh Osborne which took place on April last. Mr
Osborne had acted as Convenor for more than twelve years
and during that period grudged no trouble in attending
to the interests of the Tenace. His consideration for the wishes
of each proprietor was as marked as his capacity in the
conduct of the business. The meeting instructed the Hon
Secy to send an excerpt from this minute to Miss Osborne
with an expression of their deep sympathy with her in
her bereavement.

Mr F.A. Robertson was then unanimously elected Convenor in place of the late Mr Hugh Osborne.

The Secretary reported that Mr Dalrymple the Tramways Manager had refused to move the tramway stopping place opposite the centre of the Terrace and after discussion it was remitted to a Committee consisting of the Convenor & Mr Ferguson to see the Convenor of the Tramways Committee of the Corporation & to take such other steps as they might consider necessary & advisable in the matter.

The Secretary read a letter from Mr Waddell expressing his disapproval of the proposal to form a gate in the Terrace railing & informed the meeting that the Rev Mr Dean was in favour of the proposal. After discussion it was unanimously resolved not to construct a gate.

The assessment for 1926-7 was fixed at £7:10/-.

The Secretary reported that the wall at the east end of the Terrace had been damaged in a motor collision between Mr Clifford Strain 20 Ken Terrace & Mr F.M. Trussel Motor Hire Gowena Lane. The cost of repairs was £1:17:6 but both parties refused to pay the cost each blaming the other. After discussion the Secretary was instructed to take a small debt action against both parties for payment of this sum.

It was decided to lay granite chips on the Terrace

and the Secretary was instructed with the Comtee to do this at a suitable time having regard to the fact that the Corporation propose to lay electric cables along the Terrace for the conversion of the lighting from gas to electricity. The Secy was also instructed to buy any wood metal that might be necessary.

The Secretary was instructed to pay the Glasgow Corporation ac for pruning etc the trees on the terrace and it was remitted to the Comtee to decide as to whether some present should be given to Mr Matthew, ^{the Parks Superintendent} in token of the gratitude of the proprietors for his advice & help. They was authorized to spend up to £5:5/- in this connection. The question of putting in a pivot hedge in place of the present thorn hedge was deferred for later consideration.

The Secy reported that the painting had been done & he was instructed to allow ~~the~~ credit to the various proprietors who had recently had their railings painted themselves in respect that only one coat was necessary, the credit to amount to 13/- each.

It was remitted to the Comtee & Secretary with full power to take any necessary action regarding the conversion of the Terrace lighting from gas to electricity. They were instructed to deal with the Corporation in all matters appertaining thereto including the substitution of ornaments for the lamps at the pillars at either end of the Terrace.

The meeting concluded with a vote of thanks to the

A letter of complaint from a lady in Belhaven Terrace regarding the alleged rudeness of David Stevenson the gardener was read & after hearing a statement on the matter from the Secretary the meeting unanimously approved of the gardener's action.
